Section 4: First aid measures

4.1. Description of first aid measures

- Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor.

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Alcohol or polymer foam. Carbon dioxide. Dry chemical powder. Do not use water. Use water spray to cool containers.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: Extremely flammable. In combustion emits toxic fumes. Forms explosive air-vapour mixture. Vapour may travel considerable distance to source of ignition and flash back.

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6.1. Personal precautions, protective equipment and emergency procedures

The material will rapidly evaporate - ensure sufficient ventilation Absorb into dry earth or sand. Transfer to a suitable container. Refer to section 13 of SDS for suitable method of disposal.
